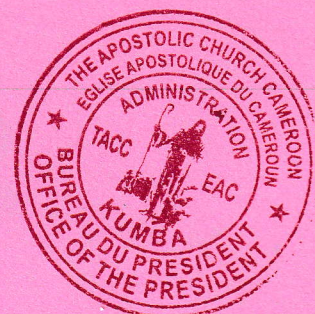
## To all Pastors, Officers and Saints;

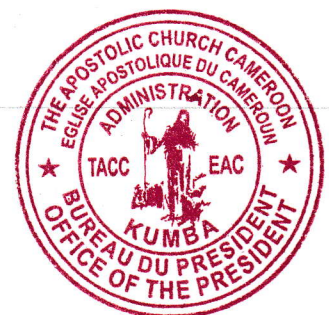

The National Council meeting in her November session of 2024 and after fasting and prayers, led by the Holy Spirit took the following decisions:

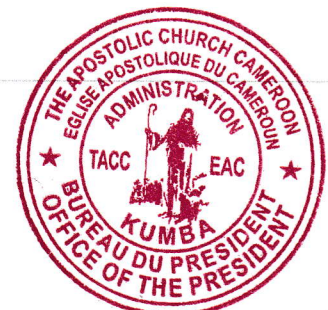
- APPOINTMENTS:** The following appointments have been made:
  - New Assistant Acting Field Superintendents:** The following Pastors have been appointed as Assistant Acting Field Superintendents effective from 1<sup>st</sup> January 2025. They are Rev. Paul Tom Kamga, Rev. Timti Joel, and Rev. Mokube John
  - New Assistant Field Superintendents:** Rev. Ukeagbu Joachim and Rev. Jean Baptist Nyebe have been appointed as Assistant Field Superintendents effective from 1<sup>st</sup> January 2025.
- New Assistant Supervisors:** Rev Mumba Emmanuel has been appointed as assistant supervisor as from 1<sup>st</sup> January 2025.
- New Groups:** The following new groups have been created
  - Mbongo Group (60) in Field 6:** made up of Mbongo as headquarter, Illoani, and Boa Balondo districts.



- ii) **Bamusso Group (61) in Field 13** made up of Bamusso as headquarter, Matutu, Basenge, Edikidem and Iyeosim.

    - ii. Kombe 1 district in group 54 made up of Kombe 1, Kombe 2 and Kotto up.
    - iii. Cocotier Autonomous Assembly in Group 30
5. **New Centers:** the following new centers have been created effective from 1<sup>st</sup> January 2025:

12. **SUSPENSION OF APPOINTMENT:** Rev Atabong Peter's appointment as Assistant Field Superintendent has been suspended till further notice.

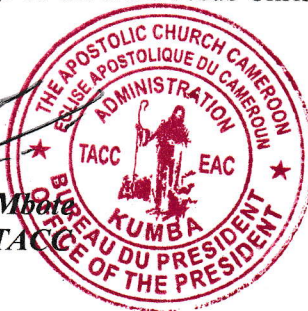
