The National Council met recently and after prayers and seeking the face of the Lord, the following decisions were arrived at:

- ASSISTANT GROUP SUPERVISOR: Rev. Laodane Mathieu has been appointed Assistant Group Supervisor as from 1st July 2025.
- NEW FIELD COUNCIL MEMBERS: The following Pastors have been appointed as Field Council members in the following Fields as from 1st July 2025, they are:

- 10. TRANSFER EXECUTION FORM: All Pastors working with TACC should note that henceforth, those on transfer must sign the Transfer Execution Form before moving into their new stations; failure to sign the execution form implies that you have rejected the transfer decision hence, no send-forth will be accorded or a delegate assigned to handle the ceremony. Such a staff will be expected to quit the Pastor's house upon arrival of the new Pastor.
- 11. **PROOF OF MINISTRY:** Henceforth, students who graduate from the seminary as from 2024, must show proof of ministry by planting a church within their former districts before any eventual integration into full time ministry.
- 12. **TABS DISTRICT:** Church Street Assembly now functions under TABS District with Rev. Aseh Richard as the Assembly Pastor.
- RESTORATION: Rev. Atabong Peter has been restored as Assistant Field Superintendent as from 1<sup>st</sup> April 2025.
