

**Note:**

1. Each Pastor on TRANSFER shall pay 20% CASH from his send-forth service proceeds, NO DEDUCTIONS should be made before calculation of the 20%. Calculations shall be done on the FULL AMOUNT of the Send-forth service proceeds.
2. According to International law, Human Rights and TACC Policy, nobody has the right to refuse transfer; transfer is by necessity. Anyone who refuses transfer has absconded from duty. Hence, each Pastor is requested in the fear of God and agreement with the Lord to resume service in his new station - "serve Him wherever He sends you".
3. If a Pastor knows that he will not resume service in his new station, he should not accept Send-forth service and the proceeds.
4. Every Pastor shall respect the date of movement, make proper planning and negotiation with the Pastor making the arrangements.
5. No Pastor shall carry any unlawful items in course of the transfer movements. The church shall not be responsible if this point is violated.
6. Each Pastor on TRANSFER should apply for A SPECIAL PASS and attached it to this Transfer Schedule either from the D. O. S. D. O. of their areas, so that there will be no disturbances on the way.
7. Each Pastor should know that in cause of the movements; respect of law and order of the land should be maintained.
