- 2. NEW FIELD COUNCIL MEMBERS:** The following Pastors have been appointed as New Field Council members in the following Fields, they are:
 - a. Field 2:** Rev. Abbey Martin
 - b. Field 4:** Rev. Indu Elias
 - c. Field 14:** Rev. Mbi Gideon
- 3. NATIONAL SUNDAY SCHOOL:** Sr. Taboh Florence has been appointed to work in the Sunday School department in charge of Fields 3 and 17 as from 1st January 2026.

4. **TABS ANNEX YAOUNDE:** The National Council has approved The Apostolic Bilingual Seminary Annex Yaounde to go operational as from 1st October 2025. The Seminary Annex shall be offering Diploma and Certificate in Theology.
5. **BUSINESS CENTER:** The following decisions were made concerning the Business Center:
 - a. **Head of Business Center:** Rev. Ambe Lawrence has been appointed to be in-charge of the Business Center of The Apostolic Church Cameroon as from 1st November 2025. He shall report to the Finance Office through the Secretary General.
 - b. **Printing Press:** The NC announces as a decision that henceforth as from 1st November 2025, that all documents related to TACC MUST be printed in TACC Printing Press. This includes all TACC institutions and church documents (Membership Cards, Marriage Certificates, Baptismal Certificates, Dedication Cards, Communion Cards, Tithe Cards and all related cards). No private printing of any church document will be allowed to be printed by any Pastor. Defaulters will face the disciplinary council of the Church. All TACC documents henceforth shall carry "TACC Printing Press". Any TACC document including Posters, Banners, Flex, Handbills etc that do not carry this inscription will not be recognized.
6. **ORDINATION:** The following Pastors have been approved for ordination in Field 14, they are: Pastors: Paul Ayire, Eboa Adolf Diange and Patrick Bate.
7. **COOPTED PASTOR:** Elder Henry Lyonga of Small Soppo District has been called as Co-opted Pastor as from 1st Nov. 2025
8. **RESTORATION:** Rev. Okon Emmanuel has been fully restored to Field Superintendent as from 1st November 2025.
9. **NEW DISTRICTS:** The following New Districts have been created as from 1st January 2026:
 - a. **Field 2: Bwitingi District** made up of Bwitingi as H/Q and Bweteva assemblies in Group 2.
 - b. **Field 11: PK 10 District** made up of PK 10 as H/Q and Genie Militaire assemblies in Group 17.



10. AUTONOMOUS ASSEMBLY: The following autonomous assembly has been created to go operational as from 1st January 2026, that is:

- a. **Etam Assembly** in Group 45, Field 15.

11. NEW GROUP: The following New Group has been created to go operational as from 1st January 2026 in Field 15:

- a. **NGUTI GROUP (Group 63):** made up of Nguti as Group H/Q, Manyemen, Ayong, Wone, Koba and Mwangale Districts.
